DEFENSE BUSINESS BOARD MEETING MINUTES FEBRUARY 29, 2024

Public Attendees

The DBB received 37 requests from the public to participate in the open session. A list of all public attendees is attached as an addendum to these minutes.

BEGIN OPEN SESSION

At 3:00 PM on February 29, Ms. Cara Allison Marshall began the open session and turned the floor over to the Board Chair, Hon. Deborah Lee James, to welcome members and provide opening remarks.

From 3:05 - 3:50 PM, Mr. Stan Soloway, along with the Business Transformation Advisory Subcommittee members, presented the study, *Creating a Digital Ecosystem*, to the full board and members of the public. The highlights of the subcommittee findings and recommendations include:

- Centralized Leadership for Digitalization: Utilize the Deputies Management Action Group (DMAG) or establish a similar body as the central authority for advancing the Defense Digital Ecosystem, facilitating industry engagement, and overcoming barriers to change.
- Develop Collaboration Platforms: Create collaboration and data exchange platforms to enhance interaction with DoD suppliers, ensuring real-time data availability throughout program lifecycles.
- Digital Taxonomy Implementation: Develop a common language, guidelines, and best practices to enable effective communication and decentralized transformation efforts within the DoD.
- Stakeholder Participation in Ecosystem Planning: Engage all stakeholders across program lifecycles (e.g., contracting officer, engineers, designers, logisticians, manufacturers, sustainers, operators, etc.) to define end-state requirements, safeguard acquisition processes, and connect sustainment and performance data.
- Change Management Strategy: Establish a deliberate change management process, incentivize digital skills adoption, and reward personnel to foster a culture conducive to digital transformation.
- Workforce Development for Digitalization: Create distinct digital ecosystem pathways for military and civilian personnel, recruit specialized technical talent, and invest in critical skills development. Assign Office of Secretary of Defense (OSD) Personnel & Readiness in collaboration with the Chief Digital and Artificial Intelligence Office to develop a strategy to rapidly recruit highly specialized and in-demand technical disciplines that support digital modernization initiatives.
- Management of Intellectual Property (IP): Mandate regular progress reports on DoD IP developments, address outstanding IP issues, and report to the Deputy Secretary of Defense through the DMAG, or similarly scoped body.
- Establishment of Centralized Funding: Create an OSD Managed fund to support digital initiatives, accelerate enterprise-wide digitalization, and provide flexibility in resource allocation beyond the constraints of the Program Planning Budgeting and Execution (PPBE) process.

From 3:50 – 4:25 PM, the board engaged in deliberation. Hon. James inquired about the cost of implementing recommendations, noting the necessity of Congressional approval. Mr. Soloway responded, acknowledging the absence of a precise figure but stressed the importance of initiating actions within the Department regardless.

Hon. Dave Walker raised concerns about managing existing systems and assigning responsibility for the implementation. Mr. Soloway highlighted the need for disciplined change management, drawing parallels with commercial practices. COL Greg Bowman emphasized the importance of assessing and eliminating outdated systems, drawing examples from industry practices. Mr. Craig Albright outlined industry practices for resource allocation and gradual phasing out of obsolete systems in line with digital architecture requirements. Mr. Soloway reiterated the significance of workforce training and the proposed leadership structure for overseeing the transformation effort.

Mr. Dave Beitel inquired about data standards and suggested a centralized support group with a federated model. Mr. Anand Bahl and Ms. Marachel Knight elaborated on the need for centralized governance with federated execution to handle data exchange effectively. GEN Larry Spencer emphasized the necessity of top-level leadership for effective implementation, questioning the organizational capacity of the DoD.

Brig Gen Bernie Skoch sought clarity on the proposed timeline and expressed skepticism about the pace of change within the Department. Mr. Soloway acknowledged the early stages of progress and highlighted varying levels of advancement across different branches.

Hon. Walker stressed the need for a dedicated executive reporting structure for business transformation.

Hon. James sought clarification on industry practices regarding dedicated governing bodies for transformation efforts. In response, COL Bowman and Ms. Knight highlighted industry practices involving dedicated offices or executive sponsors for digital transformation initiatives. Mr. Soloway differentiated between incremental and aggressive approaches to change, advocating for strategic steps aligned with enterprise efforts. GEN Joe Votel underscored the necessity of active steps to drive significant organizational change, particularly in transitioning to digital ecosystems.

The deliberation concluded with an agreement on the importance of decisive action and strategic leadership in implementing a digital ecosystem within the Department.

The Chair then called for a vote to approve the study and the motion was passed unanimously. There were no comments received from the members of the public.
